

## **DIRECTIONS FOR USE**

- 1. Provide adequate ventilation.
- Warm up engine for easier cleaning and turn off. Remove air filter. Protect carburetor, distributor and any electronic components.
- 3. Shake can thoroughly before use. Note: There is no ball agitator inside the can. For best results, the aerosol can should be at room temperature before spraying.
- Holding can 8 to 10 inches from the surface, press the nozzle and apply an even coat of product on the surface. Allow to foam for 10 to 20 minutes depending upon the amount of soil buildup. Repeat cleaning process if necessary.



 Rinse with a mild stream of water. Collect run-off with plastic sheet placed under the motor. Idle engine to dry.

- Dispose plastic sheet in accordance with state and local regulations
- Clean hands with Permatex® brand hand cleaners.
